#### **About cookies**

# Information collection & use

This website does not collect any personal information about you, nor do you need to submit any personal information in order to use the site.

## Disclosure of information to third parties

### **Duration**

Lus Health keeps the personal data collected via our Website for a period that you are a potential customer (in this case we delete the data after 2 years, if you have not become a customer) and when you are a customer, for the duration when you are a customer plus the duration of our legal, fiscal or judicial obligations or needs. If you are a supplier, we will keep your details for the duration when you are a supplier plus the duration of our legal, fiscal or legal obligations or needs.

# Your rights as a data subject
